**AMENDMENT No. Ten (10) to
Memorandum of Understanding No. 3 0 0 0 3 6 6 8
FOR**

**Memo of Understanding between the Portland Bureau of Transportation and the
Central Eastside Industrial Council Transportation and Parking Advisory
Committee for the Allocation of Parking Permit Surcharge Revenue**

This Amendment No. Ten (10) amends Memo of Understanding No. 30003668 dated the 24th day of April 2013, by and between Central Eastside Industrial Council a Transportation Parking & Advisory Committee, and the City of Portland, a municipal corporation of the State of Oregon ("City") by and through their duly authorized representatives. This Amendment may refer to Contractor and City individually as a "Party" or collectively as the "Parties."

The Effective Date of this Amendment is July 1, 2020. The purpose of this Amendment is to update the Scope of Work & extend the term of the contract thru June 30, 2021.

The Memo of Understanding was previously amended as follows:

Amendment 1, dated 7/23/2014, which increased the original not-to-exceed amount of the Memo of Understanding from \$63,006 by \$30,668 to a new total not-to-exceed amount of \$93,674, and which extended the Term from 7/1/2014 to 6/30/2015.

Amendment 2, dated 9/18/2015, which increased the prior not-to-exceed amount of the Memo of Understanding from \$93,674 by \$38,172 to a new total not-to-exceed amount of \$131,846, and which extended the Term from 7/1/2015 to 6/30/2016.

Amendment 3, dated 7/1/2016, which increased the prior not-to-exceed amount of the Memo of Understanding from \$131,846 by \$75,050 to a new total not-to-exceed amount of \$206,896, and which extended the Term from 7/1/2016 to 6/30/2017.

Amendment 4, dated 9/26/2017, which increased the prior not-to-exceed amount of the Memo of Understanding from \$206,896 by \$591,680 to a new total not-to-exceed amount of \$798,576, and which extended the Term from 7/1/2017 to 8/30/2017.

Amendment 5, dated 11/15/2017, which increased the prior not-to-exceed amount of the Memo of Understanding from \$798,576 by \$1,115,850 to a new total not-to-exceed amount of \$1,914,426, and which extended the Term from 9/1/2017 to 6/30/2018.

Amendment 6, dated 7/1/2018, which increased the prior not-to-exceed amount of the Memo of Understanding from \$1,914,426 by \$1,436,068 to a new total not-to-exceed

amount of \$3,350,494, and which extended the Term from 7/1/2018 to 6/30/2019.

Amendment 7, dated 7/1/2019, which increased the prior not-to-exceed amount of the Memo of Understanding from \$3,350,494 by \$2,168,071 to a new total not-to-exceed amount of \$5,518,565, and which extended the Term from 7/1/2019 to 6/30/2020.

Amendment 8, dated 3/4/2020, replaced Exhibit A of Amendment 7 with updated Exhibit A.1. Change PM on Memorandum of Understanding.

Amendment 9, dated 4/22/2020, Replaced Deliverable due date of Item 7(a) Transportation Parking & Advisory Committee from original date of March 31, 2020 to new date of January 1, 2021.

The Parties agree to Amend the Memo of Understanding as follows:

1. Update the Scope of Work per Exhibit A, and update the 2020-2021 Budget per Exhibit B to Amendment 10 to contract 30003668 which are attached & by reference are included in the MOU by said reference.

All other terms and conditions of the Memo of Understanding remain unchanged by this Amendment and in full force and effect.


